#### MCA EXECUTIVE DIRECTOR – Kim Scherger

The year 2022 was another one to remember as we were living through a different phase of the pandemic; it started off with unknowns, but we had the knowledge that overnight camp was going to happen this summer – finally. Then we were able to announce the \$750,000 sector-specific funding awarded to MCA to be given to our qualified Manitoba owned and operated camps: best day ever. A committee was formed from the MCA staff, the board of directors and the Manitoba Government and the planning for application process began. About six weeks after the application deadline at the end of May, the mountains of paperwork had been sifted through from 32 camps and cheques for 90% of funding for fixed costs (approximately 29% of those costs) were mailed out to the 31 successful camps. A little drop in the bucket to help offset some of the never-ending expenses that continued through the pandemic for our camps.



We were able to hold our annual MCA – CCI Linked Conference in early March; public health rules changed on the first day of the conference which allowed us to accommodate a few more attendees. It was great to be together "conferencing" and learning together again for the first time since 2019, out at Camp Manitou.

The MCA/Sunshine Fund got back to promoting at events in 2022, including the Manitoba Outdoors Show where we introduced our generic "camp" theme and had some MCA camps participate with us for some one-on-one conversations with over 5000 people in attendance over the weekend.

Then we were the main sponsor at the Manitoba Moose hockey game at the end of March, having discounted and free tickets for some SF families and promoting the Sunshine Fund and our accredited camps – to go to and to work at, while advertising through announcements and on the jumbotron and the LED circle around the Canada Life Centre.

The spring and early summer saw our Sunshine Fund applications increase to 403, getting closer to where we were prepandemic. Parents and kids were all not quite ready for camp yet. Our donors (62% of our donors were returning donors in 2022, and the national average is 51%) continued to give to the Fund. We spent \$144,397.69 to send our 403 campers to our accredited MCA camps – wonderful!

We celebrated our donors with a luncheon in September and continued fostering our relationships with these wonderful people and camps. Other highlights at year end were interviewing some amazing people for the new position we planned for (Community Outreach Coordinator) to start early in 2023 and Kim and Rick attending the CCI National conference in Banff, AB. Then we geared up with another amazing year end campaign which brought in over \$45,500.

As we plan for continued growth with the MCA and the Sunshine Fund, we are looking at ways to get more children to camp, promoting the importance of going to camp for all children, youth and young adults and working with more camps to become a part of the dynamite organization we call the Manitoba Camping Association.

My thanks go to the incredible team I work with – Dana, Rick, Michelle and Sydney, who make our work exciting, and together we are encouraging and supportive of each other.

Thanks also to the MCA Board of Directors – you are there checking in with me and supporting our amazing organization with your expertise in many different areas in and out of the camp community. I will miss those of you who have finished your terms – Danial, Audrey and Connor - and look forward to continued collaborations with you. Lastly, thanks to our member camps and those thinking about joining the MCA; I appreciate our conversations and the continued relationships and work we do together. You all make my work enjoyable.
